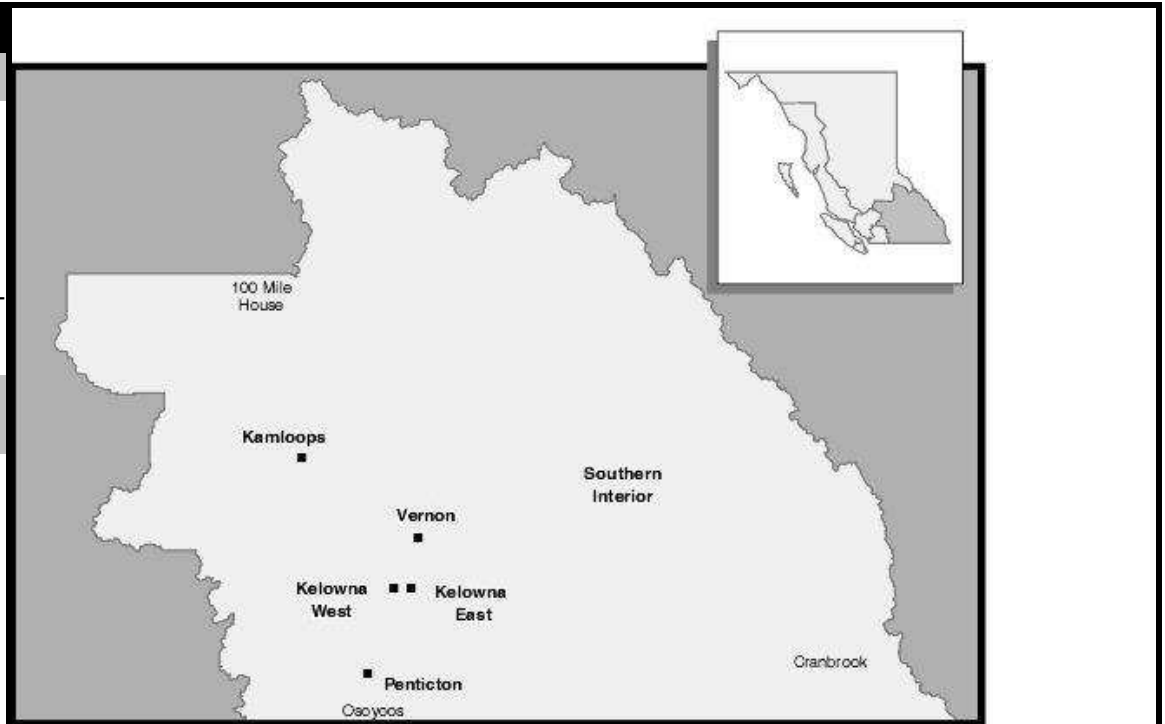
### The attached listings are divided into two sections.
