Domestic Violence Safety Planning Online Training

The **Domestic Violence Safety Planning Online Training** is a practical resource for front-line support workers as they safety plan with women, children and families impacted by domestic violence.

In response to the need for enhanced safety planning and cross sector coordination to address domestic violence, BC Housing in partnership with the Community Safety and Crime Prevention Branch (CSCP) and in collaboration with BC Society of Transition Houses (BCSTH), Ending Violence Association of BC (EVA BC) and Police Victim Services of BC, developed this online domestic violence safety planning course.

The **8-10 hour** online domestic violence safety planning training consists of 7 modules covering a range of topics including:

- working with women who have experienced domestic violence
- cross-sector coordination
- risk identification and safety planning
- safety planning with children and youth

ELIGIBILITY REQUIREMENTS

The training will be available to **support workers, management staff, volunteers and practicum students** that meet the following requirements:

- Work for a BC Housing funded Safe Home, Second Stage Housing, Transition House Program, or for a homeless shelter or outreach program.
- Have consent to take the training from their employer.
- Confirm that you are aware you have 60 days to complete the training, from the day when your username and password are emailed to you

Does it cost money to take the training?

BC Housing will pay the online registration fee, but will not be able to cover any additional costs associated with taking the training (for example, worker time).

Will I receive a certificate for completing the training?

Each learner who completes the training will be able to download a 'Certificate of Completion' by following the instructions at the end of the training.
