Report Context

The *Monthly New Homes Registry Report* provides information on new home registrations, which occur before the issuance of building permits and housing starts. As new home registrations are subject to change, they should be considered as planned or proposed projects. The report is intended for use by the residential construction industry, real estate community and researchers.

General Highlights

- In the first five months of 2024, 18,892 new homes were registered¹ in B.C., including 2,633 single detached² and 16,259 multi-unit homes³.
- So far in 2024, total home registrations¹ are down 1.4% from 2023. Registrations for multi-unit homes³ decreased 0.5%, while registrations for single detached homes² decreased 6.2%.
- In May, 2,620 new homes were registered¹ in B.C., a 44.6% decrease compared with May 2023.
- Using a 12-month moving average⁴, there were 3,750 new registered homes¹ in May, a 4.5% decrease from April for all registered new homes.
- Metro Vancouver accounted for 61.7% of all new homes registered¹ in May. Surrey (611), Burnaby (332) and Vancouver (171) were the top three cities in registered new homes this month.
- In May, there were more multi-unit homes than single detached homes in Colwood, Lillooet, Radium Hot Springs, Pemberton, Rossland, Mission, White Rock, Coquitlam, Surrey, Burnaby, Prince George, Campbell River, Langley*, Langford, North Vancouver*, Grand Forks, West Kelowna, Chase, Lake Cowichan, Kimberly, Victoria and Vancouver.
- So far in 2024, 6,767 purpose-built rental units⁵ were registered in B.C. Compared with the same period in 2023, the number of registered rental units decreased 0.6%.

Figure 1: Registered New Homes¹ by Building Type, 2002–2024 Year-to-Date





Figure 2: Registered New Homes¹ by Building Type and Selected City6, May 2024





Single Detached Highlights

- In the first five months of 2024, 2,633 new single detached homes were registered² in B.C. Compared with the same period in 2023, single detached registrations decreased 6.2%.
- In May, 541 single detached homes were registered². Compared with May 2023, the number of single detached registrations decreased 12.5%.
- Using a 12-month moving average⁴, there were 518 new single detached registered homes² in May, trending at a 1.2% decrease from April.
- Using a 36-month moving average⁴, there were 659 new single detached registered homes² in May, which is a 2.2% decrease from April.
- Vancouver (65), Surrey (31) and Burnaby (30) had the largest number of single detached homes registered² in May.

Figure 5: Registered Owner-built Homes®, 2002 -2024 Year-to-Date




Figure 6: Registered Single Detached Homes' by Selected City® in Metro Vancouver, 2023-2024 Year-to-Date




Figure 7: Registered Single Detached Homes² in Metro Vancouver, 2002–2024 Year-to-Date



Enrolled Multi-unit Highlights

- In the first five months of 2024, 9,492 new multi-unit homes were enrolled¹⁰ in B.C.
 Compared with the same period in 2023, multi-unit enrollments decreased 0.5%.
- In May, 911 multi-unit homes were enrolled⁹. Compared with May 2023, the number of multi-unit enrollments decreased 69.7%.
- Using a 12-month moving average⁴, there were 1,646 new multi-unit enrolled homes¹⁰ in May, trending at a 9.6% decrease from April.
- Using a 36-month moving average⁴, there were 2,008 new multi-unit enrolled homes¹⁰ in May, which is a 2.0% decrease from April.
- There were 150 new multi-unit buildings enrolled¹⁰ in May. Most of these were duplexes (42.7%) and buildings of 5 to 50 units (23.3%). The largest building of 97 units was proposed to be built in Surrey.
- In May, Surrey (338), Vancouver (104) and Rossland (89) had the largest number of multi-unit enrolled homes¹⁰ in B.C.

Figure 9: Enrolled Multi-unit Buildings¹⁰ by Building Size¹¹, May 2024





Figure 10: Enrolled Homes in Multi-unit Buildings¹⁰ by 12-Month and 36-Month Moving Averages⁴, May 2024



Purpose-built Rental Highlights

- In the first five months of 2024, 6,767
 purpose-built rental units⁵ were registered in
 B.C. Compared with the same period in 2023,
 the number of registered rental units
 decreased 0.6%.
- So far in 2024, rental units⁵ represented 41.6% of all multi-unit registrations.
- This month 1,168 rental units were registered¹¹. Compared with May 2023, the number of rental units registered increased 5.4%.
- Using a 12-month moving average⁴, there were 1,586 rental units registered⁵ in May, trending at a 0.3% increase from April.
- Using a 36-month moving average⁴, there were 1,359 rental units registered⁵ in May, which is a 0.2% increase from April.
- There were 23 rental buildings registered⁵ in May. Most of these were buildings of 5 to 50 units (34.8%) and buildings of 51 to 100 units (30.4%). The largest building of 180 units was proposed to be built in Burnaby.
- In May, Burnaby (292), Surrey (242) and Coquitlam (109) had the largest number of rental units registered⁵ in B.C.

Figure 11: Purpose-built Rental Units⁵, May 2024




Figure 12: Purpose-built Rental Buildings⁵ by Building Size¹¹, May 2024





Figure 13: Purpose-built Rental Units⁵ by 12-Month and 36-Month Moving Averages⁴, May 2024

Background and Methodology

BC Housing is responsible for the administration of the *Homeowner Protection Act*, with a mandate to help bring about improvements in the quality of residential construction and increase consumer protection for buyers of new homes in British Columbia (B.C.). Under the Act, all new homes in the province must be registered with BC Housing. The registration of new homes in the public registry must occur prior to the issuance of building permits and housing starts. The new homes registry data measures residential construction activities at the beginning of a project before construction commences. Therefore, information in the Monthly New Homes Registry Report is a leading indicator of housing activity in B.C.

New home registration data is collected from Licensed Residential Builders and owner builders through the New Home Registration forms and Owner Builder Authorization applications. Over time, some minor adjustments may be made to the new home registration data as registrations are withdrawn or cancelled from home warranty insurance.

This report provides information on registered new homes by building type, building size, and building location. Figures for registered new homes include both multi-unit and single detached new homes enrolled with home warranty insurance, Owner Builder Authorizations, and, since the August 2016 report, purpose-built rental buildings that are exempt from home warranty insurance.

CSA-approved manufactured homes (modular homes, mobile homes and factory-built homes), floating homes, non-stratified hotels, motels, dormitories and care facilities are excluded from the definition of new home and are not reflected in the report.

Geographical terms in this publication are based on Statistics Canada's 2006 Census area. In February 2009, the regional district of Comox-Strathcona was replaced by two successor regional districts, Comox Valley and Strathcona.

Research

In collaboration with BC Housing, the Bank of Canada conducted a study in 2016 to assess whether or not new home registration data can be used as a leading indicator for economic activity in B.C. Study findings reveal that quarterly increases in new registrations for single detached homes have statistically significant predictive content for growth in real Gross Domestic Product (GDP) over the next one to three quarters, providing stronger signals compared to housing starts and building permits over this forecast horizon. End Notes

- ¹ Registered new homes includes: single detached and multi-unit homes enrolled in home warranty insurance, single detached homes constructed by an owner builder not covered by home warranty insurance, and purpose-built rental units that are exempt from home warranty insurance. Before August 2016, calculations of registered new homes in this report excluded purpose-built rental units.
- ² Registered new single detached homes includes new single detached homes enrolled with home warranty insurance or with Owner Builder Authorizations issued by the Registrar.
- ³ Registered new homes in multi-unit buildings (two or more dwelling units) include new homes enrolled with home warranty insurance and new homes in purpose-built rental buildings with a home warranty insurance exemption. Before August 2016, calculations of registered new homes in multi-unit buildings in this report excluded purpose-built rental units.
- ⁴The trend analysis with moving average is based on a twelve-month and 36-month simple moving average of the monthly new home registration data. Data are not seasonally adjusted.
- ⁵ Purpose-built rental refers to new rental homes in multi-unit buildings that qualify for exemption from home warranty insurance. These exempted homes must be constructed for rental purposes, including social housing, and have a restrictive covenant registered on title restricting the sale of any dwelling unit for a 10-year period. Rental homes with a covenant may however be captured under "enrolled new multi-unit homes" if the unit is voluntarily enrolled with home warranty insurance.
- ⁶ Selected cities are the 10 cities that had the highest numbers of registered new homes in the reference month.
- ⁷ The five regional districts with the highest numbers of registered new homes in the reference month.
- ⁸ Owner-built homes refers to Owner Builder Authorizations issued by the Registrar. New homes built under an Owner Builder Authorization are exempt from licensing and home warranty insurance.
- ⁹ Selected cities are the 10 cities that had the highest numbers of registered single detached homes in Metro Vancouver in 2023.
- ¹⁰ Enrolled new multi-unit homes refers to new homes in multi-unit buildings (two or more dwelling units) enrolled with home warranty insurance.
- ¹¹ Building size is measured by number of dwelling units, which is equivalent to new homes.
- ¹² In this report, the five year average is the average of the most recently completed five years.
